SAMPLE PASTOR VERIFICATION LETTER:

I understand that NAME has submitted a religious exemption request from the COVID vaccine directive. As his pastor, I can speak to the sincerity of his faith and his request. NAME told me that after the directive to accept the COVID vaccine came out, he started searching the Scriptures as to how he should respond, and if he should accept the shot.

See the doctrine of the priesthood of the believer. Our church teaches that believers should follow their conscience, as informed by the written word of God, and the leading of his Holy Spirit. Our church teaches the Biblical sanctity of human life, and the Biblical interdiction against abortion as the shedding of innocent blood. Many Christians understand

this interdiction to include ingesting or benefiting from products derived from or using aborted fetal cell lines.

NAME has told me that based on his review of Centers for Disease Control (CDC) guidance and position statements, and understanding of the issues, and much prayer that he might discern truth from error, and whether he should get the shot, the Holy Spirit is not allowing him to accept the COVID shot.
